Leaders must take action to improve pupils' behaviour and to eradicate any discriminatory language or unwanted sexual behaviours that make pupils feel uncomfortable and unsafe.

Leaders must design a coherent curriculum that is broad, balanced and meets the ambition of the national curriculum. They must ensure that the curriculum meets pupils learning needs and enables pupils, including disadvantaged pupils, to achieve highly across the full range of subjects.
